Robert O’Sullivan speaks at the Side Event “Policy lessons from REDD projects and new methodologies”

The Side Event will discuss different approaches and initiatives for REDD + currently submitted to the VCS and how independent certification under a credible standard like the VCS could support policy discussions at the local and sub-national level. Linked to this, we will discuss how design options can ensure the viability of REDD projects initiated by private parties or non-governmental organizations as we scale up to jurisdictional and national level accounting and crediting. The VCS Association will also present its proposed changes to the VCS 2011 standard to improve the methodology approval, the status of approved methodologies and current pipeline, and how the VCS Association can help projects to ensure a pathway forward as countries scale up to jurisdictional and national accounting and crediting.

Charlotte Streck speaks at Agriculture and Rural Development Day

Charlotte is lead speaker in the Roundtable 4 session ‘How can carbon finance harness synergies between climate change and sustainable land management to enhance agricultural development?’

Charlotte will examine how AFOLU (agriculture, forestry and other land use) projects can harness synergies between carbon sequestration, sustainable land and forest management to enhance agricultural development and identify the lessons for carbon financing in the UNFCCC negotiations.

There are significant synergies between an increase in productivity and addressing climate change in agriculture. Well designed policies and measures at the national and international level can catalyze strategic investments in sustainable agricultural research, planning and practices that will be necessary to increase agricultural productivity, mitigate poverty, reduce pressure on forests, and conserve water tables, biodiversity and soil functions.

Charlotte Streck chairs a side event of the Rainforest Alliance and the National Wildlife Federation highlighting the potential role of agriculture in REDD+

What can be achieved before/without an international climate agreement? Private sector and sub-national mitigation efforts. Of the 100 largest economic entities on earth, 37 are corporations and given the global reach of multinational companies, the private sector is playing a leading role in GHG mitigation efforts. A key example of the impact of international ‘teleconnections’ comes from the cattle industry in Brazil, where the private sector and NGOs are working together, in tandem with state government efforts, and the results are significant reductions in Brazil’s leading source of emissions. These efforts are echoed in the commitments of increasing numbers of multinationals and financial institutions to measure and reduce their GHG emissions and to take steps to reduce their impacts on forests. We will provide the latest news and data on these private sector mitigation efforts.

Moritz von Unger speaks at Side Event of the Joint Implementation Action Group JI as bridge between commitment periods

Moritz von Unger, in his role as legal counsel to the Joint Implementation Action Group (JIAG), will facilitate a side event on the future of Joint Implementation (JI) post 2012. In its Cancun Report, the Joint Implementation Supervisory Committee (JISC) recommended that CMP allow the generation of JI credits, Emission Reduction Units or ERUs, and the issuance of credits, during the so called true-up period, i.e. until sometime in 2015. The ERUs would be converted from first commitment period Assigned Amount Units (AAUs). For the time being, it is not clear whether State Parties will follow the recommendation of the JISC or not. In case CMP does not adopt a decision on the continuation of JI, the survival of the mechanism is at stake.

Speakers include Benoit Leguet (JISC Chair), a representative of the UNFCCC Secretariat, Lennard de Klerk (JIAG Chair) and Morten Prehn (Core Carbon Group).

Charlotte Streck in dialogue with the World Bank's special envoy on climate change, Andrew Steer :

Adaptation: A Little Less Conversation and a Little More Action. Managing water in a changing climate.

The World Bank is organizing a full-day side event on Thursday, December 2 2010 with the goal of raising awareness among high-level policy makers and media outside the water sector about the costs of failing to place water adequately in the climate change debate.

The need for adaptation to climate change is clearly influenced by population growth, as well as water and food security, particularly in areas vulnerable to extreme events. The event will bring together Ministers from client countries, World Bank senior management, as well as senior representatives of partner agencies, non-governmental organizations, and the private sector. It will also include non-water experts discussing adaptation to climate change from the perspective of their disciplines and illustrate how planning adaptation measures without properly considering hydrology can waste money, leaving countries unnecessarily vulnerable. By showing the importance of getting the water story right and the costs of postponing some difficult water-related decisions, the World Bank and CONAGUA aim at influencing decision-makers to convey concerted messages and take dynamic action to tackle the issue.
